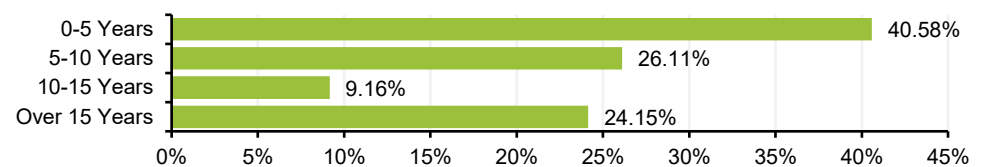

Bond Maturity



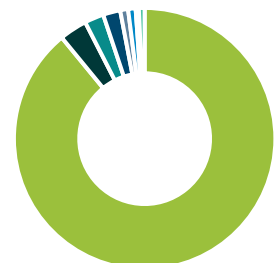
