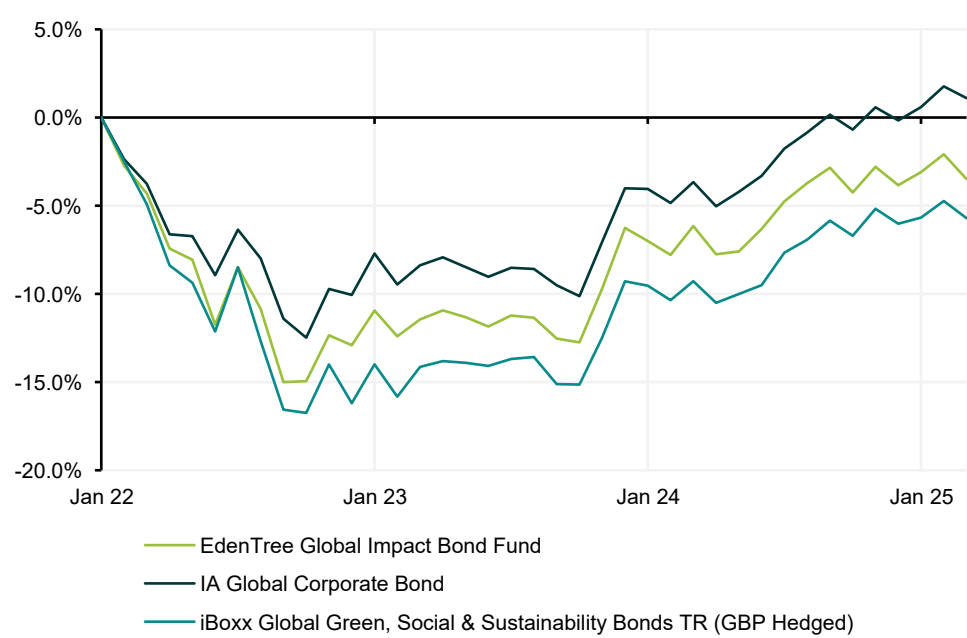
Financial Objective

This includes solutions that increase the provision of environmental solutions such as renewable energy, enable a circular economy, or improve water management. This will be measured in tonnes of carbon dioxide equivalent (CO2e) avoided on an annual basis. ii) To support an increase in access to basic services for underserved communities by investing in bonds that contribute to the following themes - Social Infrastructure, Health & Wellbeing and Education & Financial Inclusion, and engaging with the companies that issue them .

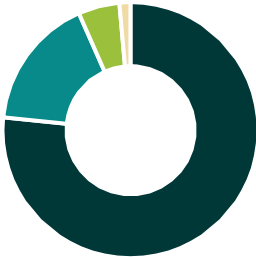

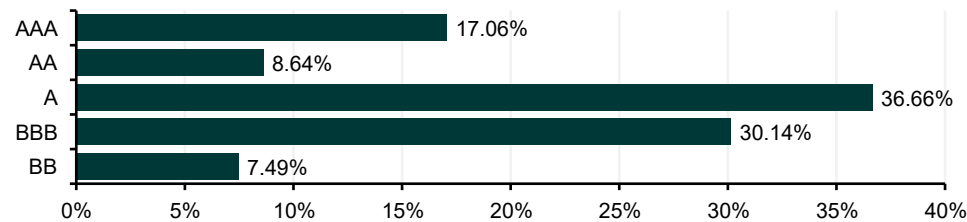


Currency Allocation

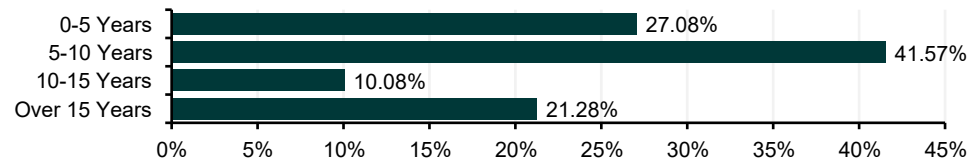
