





MULTI-ASSET SOLUTIONS WITH ESG AT THEIR CORE

We take an active approach to the Asset Allocation of our multi-asset portfolios, applying both a strategic (long-term) and tactical (shorter-term) perspective to our asset allocation decisions and fully aligning these with the portfolios' specific risk parameters.

Our three multi-asset funds are diversified across equities, fixed income, alternatives (real estate investment trusts and listed infrastructure), as well as cash.

EQUITY AND FIXED INCOME

The equity and fixed income allocations are invested directly into EdenTree's existing range of global and regional equity and fixed income responsible and sustainable investment funds. As well as benefitting from their proven track records of delivering long-term returns, our investors can trust that these portfolios are managed to our high responsible and sustainable investment standards.

ALTERNATIVES

The funds' alternative allocations will primarily be invested in listed infrastructure and real estate investment trusts. The returns of these assets are often less correlated to traditional assets, such as equities and fixed income and therefore can provide attractive diversification qualities to the core portfolio. We will work with trusted third party partners that conform to our own high responsible and sustainable investment standards.


