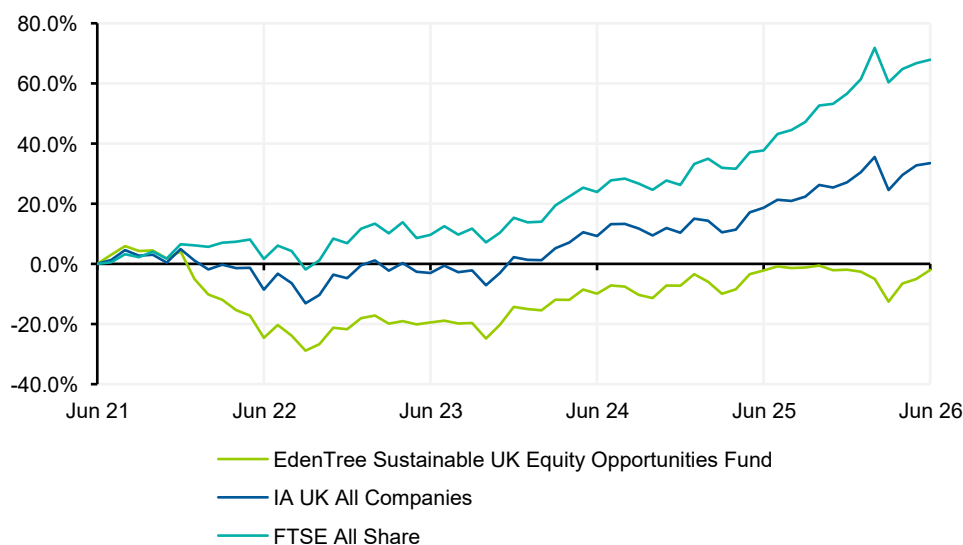

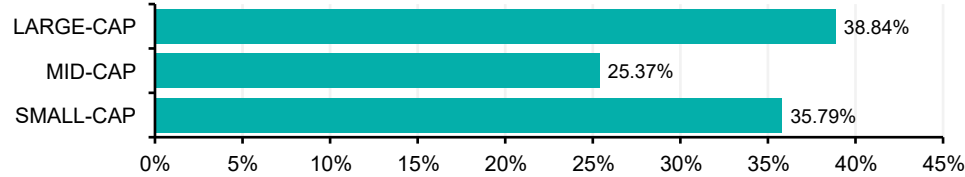

Capitalisation of Equity Assets



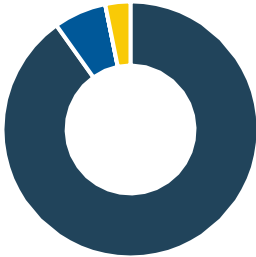
